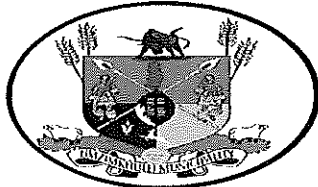

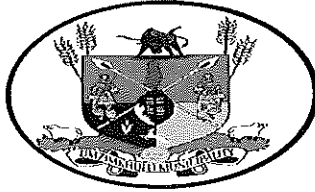

Scope of Service and Background to this Amendment

Background,

UMzimkhulu Municipality invited bids on the 18th March 2019 and the closing date for the bids was the 18th April 2019 for the service provider to provide FOR THE POOL OF PROFESSIONAL SERVICE PROVIDERS under bid number ULM- INFR 022/19. Wherefore INFINITY ALLIANCE responded to the bid and uMzimkhulu Municipality accepted the bid and appointment INFINITY ALLIANCE as the ONE OF THE ELECTRICITY POOL SERVICE PROVIDERS

THEREFORE, uMzimkhulu municipality and INFINITY ALLIANCE agreed to enter into an agreement for INFINITY ALLIANCE to provide STREET LIGHTS PROVISIONS for uMzimkhulu Municipality

It was then agreed that the service provider shall only perform only the services as they are outlined in the terms of reference and may only perform further duties that only relate to the achievement of the deliverables outlined in our terms of reference.

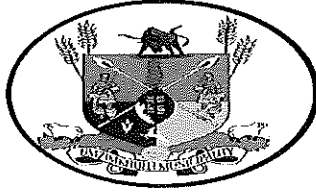
The service provider shall submit monthly report to the end user department for the works done and any other issues that might hinder her from achieving the intended objective. In turn the end user department shall submit monthly performance report to the contracts management unit

This Amendment modifies the contract between the Municipality (the customer"), Infinity Alliance (hereafter "the service provider for PROVISION OF STREETLIGHTS IN CBD AND TOWNSHIP WARD 2, 11, 12 AND 16. This Amendment does not take effect until signed by both parties.

This contract shall now include ward 17 which was erroneously omitted at the time when the terms of reference were concluded. Also to be amended is to only include the terms High Mast for ward 2, 11, 12, 16 & 17 instead of streets lights.

This is to say only ward 16 shall have name street light attached to it , but High Mast shall be constructed to all the wards mentioned above inclusive of ward 17 .
