Notice is hereby given in terms of section 116 (3) of the Municipal Finance Management Act 56 of 2003, of the proposed amendments on the contract for the professional services of the rural electrification for wards 4, 9, 13, 14 & 18.

Section 116 (3) of the above mentioned Act stipulates that:

- (a) The reason for the proposed amendment have been tabled in the council of the municipality or, in the case of a municipal entity, in the council of its parent municipality; and

 - (i) Has been given reasonable notice of the intention to amend the contract or agreement; and
 - (ii) Has been invited to submit representations to the municipality or municipal entity.

Subsequent to the tender processes and implementation of the above- mentioned project, a need has been identified to extend the scope and time of the original contract in order to ensure viability and effective service delivery.
